Following her plea of guilty but mentally ill to two counts of Murder, a felony,1 Appellant-Defendant, Magdalena Lopez, appeals her aggregate sentence of 110 years in the Department of Correction by claiming it is inappropriate in light of her character and the nature of her offense. We affirm.
